That same bird went on to win Grand Champion of the whole show (over 5500 birds). All I can say is great bird, great time and great publicity for the USC!!!

Later in this bulletin or in the next David Auerbeck will be submitting the minutes of the Annual Meeting but I would like to highlight a couple of subjects that were discussed.

1. I mentioned that I am in the USC and raise swallows for 3 reasons: 1) breeding birds that get closer and closer to the standard. 2) for the friendships and comradery. 3) exhibiting the birds that represent where I stand with #1. I then asked that everyone remember that this is hobby to be enjoyed and to not get the above priorities out of balance and ruin the experience for others.

2. We are close to having a "completed" breeder's matrix. If you have not sent me the types of swallows that you have please do. I will add your information to what I already have gathered. Shortly Gary will post the matrix on the USC website

The members in attendance liked the idea and Gary volunteered to work on that brochure so we can have it available for distribution at district and annual meets.

4. It was agreed upon that we would try and develop a new

member program and packet. If you would like to lead this endeavor please let me know.

5. As you can see my focus for the next couple of years is going to be on growing the club and increasing communications (much more to come on this in the future). Please send me your ideas and let me know if you are willing to help out.

United Swallow Club's 50th Anniversary Jubilee Show Held in Conjunction with the National Pigeon Association's 100th Anniversary Show

The United Swallow Club's 50th Anniversary Jubilee Show was, by our standards, well supported and a great success. Several breeders from all over the United States were able to attend and enjoy this milestone event. To give one some idea, it takes two to three days to travel from one side of our country to the other so one could imagine the effort it takes us to travel to our shows. You can understand and appreciate the extra effort our exhibitors made to attend this historic event. Know that climates vary throughout the United States from subarctic to subtropical. As a result, preparing birds to be in condition is very challenging especially for one specific date, our annual show.

The National Pigeon Association's 100th Anniversary Show had 5,530 entries. Coinciding with this show and a part of this historic show was The United Swallow Club's 50th Anniversary Show. The United Swallow Club's 50th Anniversary Show had almost 100 entries, definitely a strong entry for United States Swallow and Wing Pigeon Shows. As you compare these entries to those at the Zwonitz Swallow, Wing Pigeon and Color Pigeon Show, which receives around 1400 entries a year and every five years at the World Show these numbers may double; certainly the quantities are much different. However, realize our United Swallow Club's 50th Anniversary included a wide variety of swallows and a large representation of breeders from throughout our country. Definitely, an array of swallows and wing pigeons and a variety of exhibitors is a clear indicator of our club's success over time and our collective commitment to swallows and wing pigeons.

This year, I had the honor to be selected as the judge of this landmark show. Here, we judge in front of the breeders at the show. Birds are brought up by the exhibitors and displayed in large show coops for the judge to review and provide comments to the gallery of exhibitors. Our judging process includes talking to the exhibitors about the rating of each bird. Our intention for this process is to inform breeders of the judge's decision and heighten their awareness of what is seen in their birds by the elected judge. (In Germany, I believe a similar process and discussion takes place at the summer meeting). Additionally, as in European shows, we write the judge's comments on the coop cards: the rating, good points, wishes and faults. As the judge, it is my opportunity to inform those in attendance what I see in their birds. When a bird is

rated 97, if we don't have a European judge doing the judging, we have a second United Swallow Club Certified Judge confirm the bird as a 97 deserving of the E (V) rating.

Also, realize at the National Pigeon Association's 100th Anniversary a Grand Champion of all 5,530 birds entered is selected as well. The champions of all the breeds are brought together for a "Parade of Champions". A panel of three judges from the National Pigeon Association reviews the champions and together the panel of three judges selects a Grand Champion of the National, a Reserve Champion and a Second Reserve Champion. This year's NPA judges were: Orrie Moore, Longbranch, Washington; Fred Maenpa, Orange, California; and Bill Henderson, Chattanooga, Tennessee. Certainly, it is an honor to bestow the Champion out of 5,530 birds! This year's Grand Champion was a Blue Check Swallow owned by Mike and Cathy Swanson, the Champion Swallow, I selected for the United Swallow Club's 50th Anniversary and rated as 97 deserving of the E (V) designation. Nate Wayne, of Minneapolis, Minnesota, our second United Swallow Club Certified Judge, also confirmed the bird as a 97 deserving the E(V) rating. Definitely, the coinciding of NPA Grand Champion for their 100th and Champion for the United Swallow Club's 50th providing a pleasant coincidence!

Know that the United Swallow Club has a Certified Judges Program, not as sophisticated as the European system, however, it serves us well for the size of our country. Our Certified judge and show location are voted upon early in the year. The judge selected gets the opportunity to judge our annual show and airfare and hotel expenses are paid for by our organization.

Mike and Cathy Swanson received the highest honor of the best Swallow or Wing Pigeon at this show. Perry Mueller and Chris Auer, pictured, also showed top birds at this event. Our heartfelt thanks go out to the German Swallow, Wing Pigeon and Shield Club for donating three wonderful bands to our special annual show. Prior to the judging, it was determined these special bands would be shared by three different individuals. Know that by our judging system, one breeder could win all three. However, it was determined to limit one per exhibitor thus, three people could go home very happy. These are the three recipients of the banners and their winning birds:

NEWCASTLE VIRUS

For the past approximately two years, we have been under quarantine for the Newcastle Virus. It has affected parts of Southern California, specifically three counties, Riverside,

San Bernardino and Los Angeles. Strict guidelines have been set resulting in poultry shows being cancelled as well as the Fresno National. This is one of many examples of how this unpredictable virus is affecting our hobby. The task force has been continuously testing and when results are positive they euthanize any poultry within a one mile radius from the infected area. At one point, the task force and killings reached as close as two miles from our lofts. It is difficult to put into words how stressful this has been on many breeders, not knowing if their birds will be spared or euthanized. As of 2-21-2020, it has been reported that more cases were found in San Bernardino County. As to when we will see an end to the virus and when things will return to normal, your guess is as good as mine?

NEW BREEDER PROFILES

As you have noticed in this issue of our newsletter, we have started to include a member profile questionnaire which will help us get to know our members a bit more intimately. Our first featured member is Mr. Jim Grober. We hope you enjoy it.

EDUCATION AND TRAINING

I wanted to share some ideas on the subject of education and training for our members and future judges. The suggestion has been made to hold educational clinics at major shows, such as our annual meet and other shows where a large group of members attend. USC MEMBER PROFILE

Featured breeder **Jim Grober** By George de la Nuez

We are honored to have our first interview with Mr. Jim Grober from the lovely State of Wisconsin. We felt it was appropriate and timely to have Mr. Grober as the featured member, especially following his recent win at the 2019 USC meet in Des Moines, Iowa.

We hope that through these interviews we are able to get to know our members more intimately and learn a few things about them and their pigeons. Please enjoy.....

When were you born? March 12, 1951.

Where do you live? USA, in the State of Wisconsin, the city of Muskego (about 17 miles southeast of Milwaukee) I have lived here my whole life. My wife and I built a home 40 years ago on 5 acres that was part of my grandfather and father's farm.

Do you have any other hobbies besides pigeons? I enjoy vegetable and perennial gardening. I also enjoy landscaping and building. I just finished a 10' x12' storage shed for my brother in law.

For 25 years I raised and exhibited Belgian d'Uccle bantams. This breed has foot feathering and vulture hocks. When I retired 4 years ago, I decided that bantams, especially during January in Wisconsin, heat lamps, frozen water, etc., tied us down if we wanted to travel, even overnight. Prior to selling my bantams, I attended a local pigeon club meeting, the seed was planted and I was hooked. I sold and shipped all my bantams and started searching the internet for breeds.

What attracted you to Swallows? The first Swallows I saw were on the United Swallow Club's website. They reminded me of the d'Uccles with foot feathering and hocks, but also the special color patterns.

Who got you started in Swallows? My first pair of Swallows were from a gentleman in Michigan I happened to meet at the NYBS. The USC was also there and I bought four birds from Chris Auer. All of these birds were blue black bar Silesians.

How did you find out about the United Swallow Club? I primarily learned that the USC existed because of my web searches, but meeting the "club" at the NYBS that first year was pivotal. Chris Auer suggested that I join the club if I was starting with Swallows. I have never regretted that move.

What is your least favorite part of the hobby? As with any animal, keeping the space clean.

Do you have any suggestions on how to improve our club?

A. I have spoken to Chris about this, but a trifold brochure (with application in brochure) could be handed out by members at large and local shows.

B. List of club members and type of Swallows they raise. Could be used as a guide for interested parties.

C. Keep the newsletters coming on a timely basis. Don't miss a quarter, even if it's a small newsletter.

Do you feel there is enough information available out there to help breeders succeed? If not, what would help? Two things have helped me in the past 4 years. **A.** Going to major shows.

NYBS and Des Moines for me. I have learned so much from my fellow breeders. They give advice freely and honestly. **B.** Phone conversations with Chris Auer, Steve Ripper and Brad Stuckey . Others like Nate Wayne and Elliot Yeske who I see at the regional shows and have been very helpful. Bill Griebel has been my main source of blue black bars and Dave Averbeck was my source for black white bars. Each have given me help.

How long have you been in the pigeon hobby? 4 years.

Do you keep other breeds besides Swallows? I just started with a few pair of Gold Collar Lucernes.

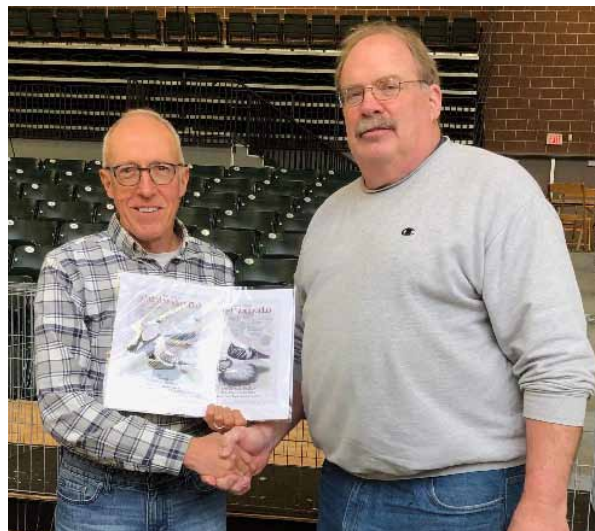
Do you have a health program for your birds? I am a "only the strong survive" kind of person. I was that way with my bantams and have the same philosophy with my pigeons. They do get probiotics in their water on a daily basis and not the same

one every day. Two years ago I lost 2 birds after the NYBS. No amount of medication or probiotics would not have saved them.

What is your feed preference? I feed Des Moines Breeder Ration, but add a small amount of 18% Des Moines Pigeon Pellet. Also add a small amount of safflower meats.

How many birds do you keep? Presently I have 15 pairs of Silesian Swallows. Less than half are black white bar and the balance are blue black bar. I expect to breed 12 pair. You'll see in the photos why I breed 12 pair. Last year I raised about 45 young and I would expect about the same this year.

Is there anything you would like to share that has not been covered? I would like to share that the United Swallow Club has been a real help to me. I'm learning new things every day and the club and its members have been invaluable.
